Section 8 of the Principal Act is amended by substituting for subsection
(2), a new subsection "(2)" –

"(2) The categories of persons mentioned in section 291 and members of the Armed Forces of the Federation in section 217 of the Constitution of the Federal Republic of Nigeria, 1999 and members of the Intelligence and Secret Services shall be exempted from the scheme".
